External Applicants

(a) Educational Qualifications

Should have obtained a degree in Sports Management / Business Administration / Public Administration / Public Management / Human Resources Management / Commerce or any other degree in the relevant field recognized by the University Grants Commission

With

A postgraduate (Master's) degree in a subject field relevant to the post or should have obtained the Associate Membership of a recognized Chartered Professional Institute compatible to the field relevant to the post

And

Should have obtained at least fifteen (15) years experience in a post relevant to the field in "Managerial Level" in Government, Government Corporation, Board, Statutory Institution or reputed private institution.

Qualifications for Internal Applicants

Should have completed a satisfactory service period of at least five (05) years in a Grade I post in Management Service (MM 1-3) service category in the relevant subject field.

And

Specific proficiency in providing leadership to teams engaged in multipurpose activities and efficient management of other resources.

Salary Scale and Category: HM 1-1 - Rs. (140,640.00 - 15 x 4,100 - 202,140.00)

Age Limit: Should be not less than 35 years and not more than 55 years as at the closing date of applications. Maximum age limit will not be applicable to internal applicants.

Salary:

Entitlement to the above salary scale will come into effect from the date of appointment as per the provisions of Management Services Circular No. 01/2025. As per the salary increments implemented under three stages, government approved other allowances will be paid with the salary specified for the post for the relevant year of appointment.

Method of Selection:

Short-listed applicants based on the highest qualifications and experience in the relevant field will be called for the interview and selection will be made based on the performance at the interview.

Nature of Appointment:

This is an appointment with entitlement for Employees Provident Fund and Employees Trust Fund.

Method of Recruitment:

Out of the applicants who fulfill the qualifications mentioned in the advertisement, one who obtains maximum marks at the interview conducted by an interview board appointed by the competent authority for appointments for the evaluation of qualifications, will be selected for recruitment to the above post. This interview for the evaluation of qualifications will be conducted as per the method of giving marks according to the recruitment procedure approved by the Management Services Department.

General Requirements and Conditions:

- Should be a citizen of Sri Lanka
- Applicants employed in government or semi government service should direct their applications through the heads of their respective institutions
- Should be physically and mentally fit to discharge the duties entrusted to the post
